#### THE PROBLEM

#### **PROJECT** BENEFICIARY

The Nicolas Witbooi Memorial School was established on 28 February 1928 by the owners of the farm, Mr and Mrs Jan and Nicolas Witbooi.

The buildings and the piece of land on which the school and buildings stand were donated to government on 9 July 2001.

The majority of learners attending this school come from poor and disadvantaged families who are workers on the surrounding farms and informal settlements.

Currently, the school offers Grade 1 to 7 curriculums. There are 263 learners who are taught by ten teachers, assisted by one school secretary.

In terms of physical facilities, the school has eight classrooms, one science laboratory and a library.

The Nicolas Witbooi Memorial School has two flushing toilet cubicles and three urinals for boys and five cubicles for girls while the staffs have

The relationship between the toilets pots to learners are as follows:

- 1 toilet pot to about 69 for boys
- 1 toilet pot for about 26 girls
- One cannot help but observe that the ratio of toilet pot to learners is quite higher for boys

In terms of teacher's accommodation, there are two family units and 2 bachelor flats respectively. The rest of the teachers are accommodated in the

supervisor's flats in the hostel which accommodate 239 boarders. The total capacity of the hostel is 232, consisting of 118 boys and 114 girls. The hostel has two blocks each for boys and girls, with 25 bedrooms for boys and girls respectively.

The school has portable water supplied by an electrical borehole. There are two water tanks which serve as reservoirs for both the hostel, school and teacher accommodation.

#### OVERVIEW

Honourable Governors noted that the project was made possible by an offer from Innv8e Group during the handover of toilets at Baumgart Brunn Primary School,

The Honourable Mcloed-Katjirua stated that the school was chosen from the profiles collected by her office in order to determine the school that was in dire need.

The school currently has two flushing toiletcubicles and three urinals for boys, indicating that 69 boys share one (1) toilet pot and approximately 26 girls share one (1) toilet pot,

indicating that the ratio of boys to girls is greater. The Honourable Governor thanked the donors and the representative and emphasised that the partnership will resolve the challenges their office is currently facing, specifically the installation of the toilets and the transportation of the toilets to the school.

The school was informed that The Governor's Office, in conjunction with Innv8e, will deliver 12 toilets (6 for girls and 6 for boys).

The school's acting principal proposed installing toilet facilities in multiple locations (2 at the staff residence, four at the soccer field, one at the security area and the rest closer to the classrooms).

This is due to the fact that there is only one unisex restroom for teachers and none near the security workstation.

suggested, however,that the location be chosen based on the functionality of the sewage system to facilitate the straightforward installation of the precast toilets.

Due to easy access to the sewage system, which enables pumping of the sewage system, it was decided that the 10 toilets (5 girls and 5 boys) would be installed next to the hostel; and two (2) restrooms will be installed in the residential area for staff members.

#### **MANUFACTURING &** TRANSPORT

Innv8e (PTY) LTD manufactured the precast Toilet units and transport the units along with all fittings to the construction site. The production and curing of these units will require 20 days.

#### INSTALLATION

The installation will be performed by our production team of four employees with a supervisor. The estimated time or period for installing 12 toilet units is 5-10 days. This included levelling and clearing the site, installing the toilet structures, and installing all plumbing.

The children suffer from fatigue, there are safety issues when travelling home so late in the afternoon and they are excluded from certain afternoon activities. Construction of the four block classrooms, storeroom and large ablution facilities immediately kicked off after the ceremony, the expected completion date is 15 December 2022

#### **AUAS PRIMARY SCHOOL**

Auas Primary School is located in a densely populated area in Katutura, Damara location. Due to the capacity constraints, the school operated on a platoon system for grade 3 learners, which accommodates some learners in the mornings (07:00 to 12:00) and others in the afternoons (12:30 to 16:30).

To address the Auas Primary School's challenge, the school required additional classrooms and ablution facilities. The DNF Board in 2020 and 2022 agreed to the funding for the erection of the following structures to the amount of N\$2.5m:

- One standard block of four classroom building including a storeroom facility
- One large male, female, teachers, and people with disabilities ablution block
- 180 Learners' desks and chairs
- 4 x Teachers tables and chairs
- 2 x Projectors with 4 x screens
- Chalk boards
- Pin boards
- Refurbishment the floor of one existing classroom

# IREMA & MAWLR small stock production training sessions

The IREMA project recently conducted the training for small stock production which took place from 02 to 15 April 2023 at Khorixas and Opuwo respectively. The training saw 25 farmers mainly 11 male and 14 female farmers and 19 farmers from marginalized groups such as the Himba, San and Zemba receiving training on small stock production.

The overall goal of the training is to enable goats' beneficiaries who received goats from IREMA & MAWLR in 2022 to increase their knowledge and skills in sustainable small stock farming and production/husbandry practices including marketing, revolving

scheme regulations and challenges faced by beneficiaries. The training was centered around improving small stock production knowledge, improving skills among beneficiaries, promote the small stock revolving scheme amongst beneficiaries and emphasis more revolving scheme bylaws.

The Environmental Investment Fund of Namibia (EIF) in conjunction with the Ministry of Agriculture, Water and Land Reform (MAWLR) is Implementing a climate change adaptation project titled "Improving Rangeland and Ecosystem Management Practices of Small holder Farmers Under Conditions of Climate Change in Sesfontein, Fransfontein, and Warmquelle Areas "IREMA Kunene Project.

The IREMA project aims to reduce the vulnerability of smallholder farmers under climate change conditions by safeguarding natural capital that generate ecosystem services to sustain agricultural production systems. Under the project activity, the project implemented the scheme to support drought resilient livestock breeds, with focus on small livestock farming practices the project managed to develop IREMA Small Stock Revolving Scheme.

In 2022 the IREMA project procured 630 goats which benefited 29 beneficiaries while Ministry of Agriculture, Water and Land Reform had also procured 441 goats which benefited 21 farmers in Kunene Region.

The training covered a duration of four days at each training site, namely Khorixas and Opuwo. At each training session, agricultural technicians from various wards were involved to ensure close support and backstopping of the beneficiaries in addition to the two interns from the Namibia University of Science and Technology (NUST) who formed part of the training sessions.

Training sessions were facilitated by the Agricultural Bank of Namibia Mentor, Extension Officers from Directorate of Agriculture Production, Extension and Engineering Services (DAPEES) and IREMA Regional Technical Officer using different training methods and techniques, including interactive presentations with illustrations; discussions; brainstorming; and question and answers.

Training handouts and other relevant literature were presented to the participants as reference materials. Participants were taken through the following issues during the training sessions.

The training covered the following topics but were not limited to animal health, record-keeping, small stock Husbandry, general body condition observations, diagnose sick, healthy goats, kraal hygiene, vaccination and dosing, marketing, flock composition, breeding and many more in general, effect of climate change and advantage of farming with small stock farming, revolving scheme concept, roles and responsibilities of beneficiaries in ensuring successful implementation of the revolving scheme.

The training enabled participants, to understand the production of small stocks, especially animal health, nutrition and animal husbandry, the impacts of the program to improve the livelihoods of the rural community.

Participants highlighted that their expectations were met, learned something new and expressed a willingness to share the knowledge gained with other farmers in their respective communities.

The participants further expressed their gratitude to the EIF/IREMA project for hosting the trainings, goats received through the IREMA project and for financial support as a result of the IREMA project.

It gives me great pleasure to be invited to this third event of the Social Agenda Sessions organised by the City of Windhoek in collaborations with its Social Enterprise partner Innv8e Pty LTD.

I am happy to be present at this engagement which brings together strategic stakeholders, donors and beneficiaries under the theme "Promoting working Partnership in the Provision of Basic Needs".

This theme is appropriate as it acknowledges the importance of collaborative partnership and new relationships that generate value towards social progression in our communities.

I therefore applaud the City of Windhoek and its Social Enterprise partner Innv8e Pty LTD for organising this event

Social enterprises are considered as agents of change and have significant role in community development. They are our partners in improving public service delivery and this is in line with the Public Sector Innovation Policy of the Government which calls for efforts to transform the public sector by improving service delivery

and ensuring that public services are responsive to the needs of the public.

The advent of Covid-19 brought about new challenges and these challenges require us to embrace new approaches to best practices to ensure that our services are customized towards meeting the citizens' needs, aspiration and expectations.

It is in this context that Government adopted a Public Sector Innovation Policy to institutionalize new ways of thinking and working. This policy calls for collaboration across sectors and the adaption of the whole-of-government approach embracing whole-of-nation perspectives in dealing with issues effecting the nation.

I wish to acknowledge contributions made and donations by stakeholders which we witnessed this morning, and those in progress to improve sanitation in the informal settlements and informal markets, contribution to the construction of the informal markets, SMEs supports and Urban Agriculture and educational financial assistance to students and assistance to victim of shack fire from the Mayoral Relief Fund. These donations will go a long way in meeting the basic needs of individuals and communities.

I call upon others to emulate these good examples, initiate sustainable projects to address pressing needs of our people in a collaborative manner, in order to achieve our development goals as outlined in Vision 2030, National Development Plans and Harambee Prosperity Plan.

Director of ceremonies, Ladies and gentleman, the State plays a role in creating an enabling environment for social enterprises to operate. In this regard the following tax benefits are in place for social enterprises:

The Government offers various tax exemptions to organizations that engage in social activities. The exemptions are not granted because the Government finds it difficult to tax but rather because these entities fulfil an important role in society that compliments certain Governmental goals and objectives.

From an income tax perspective, our tax laws grant an exemption to companies or associations whose mandate entails engaging in activities of providing social or recreational amenities to its members.

By deduction, this exemption extends to the provision of social facilities to the general public. In promoting culture across various spectra in

Namibia, any association of persons with the principal object of carrying out activities of a cultural nature is fully exempt from paying tax on its generated or earned profits.

Generally, where the constitution of any association dictates that profit will not be distributed to any person and would be retained for utilization in investment or the objects for which it has been established, such an association would be exempt from income taxation. This provision equally applies to organizations that carry out social activities and include sporting associations.

Further, our current tax law provides that charitable institutions and educational institutions of a public character are exempted from income tax. This exemption applies whether or not such institutions are supported wholly or partly by grants from publić revenue.

As consumption tax affects cash flow for social enterprises that carry out charitable work, the Value Added Tax law provides a relief in this regard. The charitable organization, children's homes, old age home and orphanages can claim the tax charged on purchases (by various suppliers) from the Government. This assists with the cash flow difficulties and there is no obligation to make any VAT payment as it is classified as zero rated supply.

Government also provide subsidies to educational and health facilities, a partnership formed to ensure that people from all walks of life have access to these facilities.

Ladies and gentlemen, it is important to point out that investing in social corporate responsibilities returns or benefits to the business as well as to employees, communities and to the nation at large.

It is for this reasons that State provide support to social enterprises programs and non-taxability of income of section 21 companies as indicated above.

Finally, Directors of Ceremonies, again commend various stakeholders and Innv8e PTY LTD for implementing projects to solve sanitation problems. These initiatives meet Government half way as we develop solutions to our challenges. Let us continue to collaborate and coordinate our efforts in addressing our challenges.

#### PRIORITIES OF CRITICAL AID TO BETTER SERVE THE **COMMUNITIES**

#### 1. PROVISION OF PORTABLE WATER IN THE **RURAL AREAS**

1.2 Ohangwena Region is one of the Regions battling with the provision of potable water to its inhabitants residing in the rural areas.

- 1.3. The main source of water in these areas is boreholes Inhabitants draw water from the wells were water is unfit for human consumption or walk long distances of about 10km to fetch water from neighboring villages.
- 1.4 The discovery of Aquifer II in Ohangwena region has opened up for further development in terms of bulk water supplies and export to other regions.

#### ACCESS ROADS IN RURAL AREAS TO ESSENTIAL **GOVERNMENT INSTITUTIONS**

The Region has largest poor road networks especially Constituencies in the eastern parts of the Region. Many Government Institutions are very difficult to be accessed, due to the fact that roads are very bad or non-existent.

#### **STRATEGIC OBJECTIVES**

#### INCREASED FOOD **SECURITY**

Food security is described as a situation when all people, at all times, have physical, social, and economic access to sufficient, safe, and nutritious food that meets their dietary needs and preferences for an active healthy life.

This is exactly the objective of the Green Economic Interventions as it should directly make an impact on the lives of the people of the region.

#### **SOCIO-ECONOMIC DEVELOPMENT**

The //Kharas region has been blessed in recent years with employment

opportunities, especially with the construction of the Neckartal Dam and the Mining and Fishing Industries. Sadly it seems like all those opportunities have dried up and have become limited.

The Green Economic Interventions, therefore, aim to use the Agricultural Sector to fill that gap through innovation and development of sustainable green projects.

#### TRAINING AND RESEARCH **DEVELOPMENT**

The inhabitants of the //Kharas region are predominantly subsistence farmers who have only been taught the old and traditional manners of small livestock farming and have failed to build resilience towards climate change through innovative technology and restructured farming techniques.

The Ministry of Agriculture through its research farm Gellap Oost will therefore look at how best to combine new technology and feed production to build resilience within the farming community.

It is also envisaged that the collaboration of the Governor's Office, DAPEES, Forestry, and the University of Namibia will create standardized training programs for the youth at farm Coenbult through NIIĎA.

The Governor's Office of the Great //Kharas Region has embarked on a journey to ensure that people are put first when it comes to development. With the numerous resources at our disposal, we have committed ourselves to ensuring the resources should benefit the people.

As we aim to reach our goal of zero hunger in the region and bring about food security to each home in the region, we have identified the agricultural sector as the key driver and catalyst to foster desired socioeconomic transformation in the region.

The drivers of the southern economy such as mining, fishing, and farming are no longer able to provide the necessary support that the economy requires for sustainable growth.

The prolonged drought has taught us that it is time to redefine and adapt to the effects of climate change or else will be left to lament our losses year after year. Covid 19 has brought out our most vulnerable characteristic as a nation, that we are too dependent on our neighboring countries, and that we are not able to produce enough for our citizens.

#### //KHARAS **AGRICULTURAL** RESEARCH AND DEVELOPMENT PROGRAM

#### PROJECT IDENTIFICATION **PROCESS**

With new and fresh energy the Governor current looked different initiatives and eventually developed the "Green Economic Interventions Plan" that looked at improving food security, socio economic development, training and research development, and decrease dependency in the //Kharas region. The plan tried to identify various areas and projects that could be implemented and to improve those already in place. Amongst them is the most dominant project that is still in its infant stage but has made great progress and shown the most potential based on the social impact that it will make.

The Coenbalt Agricultural Training and Development Center As part of the training and development aspect of "Green Economic Interventions" consultative meetings were held with the UNAM Southern Campus with the vision of developing a short or medium-term agricultural course. The objective of the course was to grant an opportunity to the youth who are not able to qualify for tertiary admission and who could not find employment, to gain skills and knowledge in the agricultural sector to empower themselves and their communities.

Secondly, a separate stakeholder engagement was held with NIDA which the office of the Governor has also identified as one of its main developing partners. The aim was to get a piece of land where the project could take place as well as the equipment needed. One hundred hectares of land were allocated for the project as well as a tractor that is already on site.

Thirdly the project should be sustainable and with a donation of rice seed from the ambassador of Tanzania the office approached the UNAM Multidisciplinary Research Center who have progressed well and have developed the advanced mushroom, and vegetable

production program.

The aspects of the full project are still under development and the final project initiation document will be finalized soon.

# INTEGRATED RICE, MUSHROOM AND VEGETABLE PRODUCTION FOR SUSTAINABLE AGRICULTURE

Researches on rice has contributed significantly in achieving food security by increasing the yield potential in both irrigated and rain fed systems. Apart from rice being a staple crop for many countries including China (Hossain et al., 1995) it is an important source of employment and income generating rehearsal in rural areas, particularly in low-income countries.

Rice is the primary source of energy. Rice husk and rice straw as important sources of renewable energy (Jeng et al., 2012, Logeswaran et al., 2020) Most rice varieties grown for human consumption contains decent amounts of fibre, protein, vitamin B, iron and manganese (Chemistry international, 2020).

This means rice can play a vital role against malnutrition. Rice production needs to be increased especially in African countries and countries with low rainfall to meet growing food need worldwide. Consequently, rice systems are interrelated with food security, water scarcity and global climate change issues (Yao et al., 2017). Increased rice yield has to be achieved with less land, less water,



and less labor to billet the demand of inputs from the intensifying nonagricultural sectors.

Rice straw is one of the most common substrates used for growing this mushroom (Huang et al., 2019). With rice straw, oyster mushroom can grow well in both outdoor and indoor conditions. Although the production of rice in Namibia has been increasing over time, especially with Kalibeza rice project, there is need to move towards sustainable land and water management.

This proposal projected an integrated process of growing rice at Hardap and Naute dams in the southern part of Namibia and use rice straw after harvesting to cultivate oyster mushroom, simultaneously spent substrate will be used as fertilizer to grow vegetables. The study can further be extended to use rice straw anaerobic digestion of spent mushroom substrate (SMS), and fertilizer value evaluation of digestate for achieving multiple products and full utilization of nutrients in rice straw.

The proposal pursues to promote mushroom production combined with rice growing consumption as part of a Zero Emission Research Initiative (ZERI) concept among the farming communities in the southern part of the country where water is natural inadequate for most farming practices.

The project will be introduced to farming communities around the two dams with the main aim of employment creation to reduce poverty among others. A vegetable garden is not an exceptional.

The seek funds to train specified communities in mushroom cultivation, rice production as well as planting of vegetables. Both communal and commercial farmers will have equal opportunity for training and a trainer of trainees' approach will apply.

#### **VALUE PROPOSITION: SERVICING OF LAND**

Municipalities/Town councils have the land and funds but their funds are applied to various needs e.g. Servicing of land; and providing of services to inhabitants of their towns for residential and business purposes. This limits their budgets.

We directly fund the municipality/ town council and this helps to minimise costs to the end user who is the beneficiary of the plot since there is no 3rd party profit.

#### THE COST FACTORS ARE:

The cost of servicing of land The Town Council's mark-up which is on average 25% depending on each respective municipality/town council.

We are involved in this to contribute to delivery of affordable land to our people. This contribution is a token of our participation in achieving the GRN objectives in terms of Vision 2030 and Harambee Prosperity Plan (HPP).

#### **SOLUTION**

The Town Council identifies the land to be serviced that is sub-divided and zoned already. We provide a loan not to be paid through operational cash flows but it is reduced by every plot/erven sold. This means that the person or institution who bought the land or erf pays towards the reduction of this loan.

In some instances FNB offer to take up plots for our staff on identified land to be serviced in order to boost sales for the municipality/town council. This is done on 'arm-length principle'.

#### **TERMS & CONDITIONS** OF LOAN

The Loan term is 3 years (negotiable). Depends on the time from servicing to the sale of the ervens, taking into consideration the appointment of contractors, subdivison of ervens, registration of title deeds and actual sales of



the plots.

The Bank may consider the following Collateral:

> (a)Lodging of individual title deeds to be released once the plot has been sold. This is the preferred option as there are no cost involved.

> b) Registration of a first mortgage bond. Not preferred due to high cost.

#### REQUIREMENTS

- Latest Annual Financial Statements (AFS)
- Costing and CFF of the project
- Lending mandates from relevant authorities. In order not to delay the process we start assessment parallel with the Town Council's applications to obtain approval from their relevant authorities.
